The following amendments were made in the tender document towards the work for Maintenance of Housekeeping, Garden and Washing empty milk tubs at Ambattur Dairy, Chennai – 98 for two years 2023-2025.

TECHNICAL BID

1)Page no.13

5.13. In the event of escalation in cost due to revision of daily wages by the District Collector or revised tax payable during the period of the contract, the successful tenderer should alone bear such escalation and the successful tenderer shall not claim any additional amount for such escalation.

May be read as

5.13. In the event of revision of daily wages by the District Collector during the period of the contract and revised order implemented in the Federation, the successful tenderer shall pay the revised rate and claim from the Federation. No change in the rate is allowed during the contract period, except the revision of Collector wages on implementation in the Federation and corresponding EPF, ESI and GST.

2)Page no.14

5.19. No revision of rate will be entertained at any cost during the contract period and on extension period.

May be read as

5.19. No revision of any tax will be entertained at any cost during the contract period and on extension period except the revision of Collector wages on implementation in the Federation and corresponding EPF, ESI and GST as in Tender clause 5.13

3)Page no:21

5.59. If the rate quoted is below the basic rate as per the minimum wages declared by The District collector, then that rate will be rejected from the commercial evaluation, even though the quoted rate is L1. In case increase of the collector wages should be revised as per the Federation order basic.

May be read as

5.59. If the rate quoted is below the basic rate as per the Collector wages declared by the District collector, that tender will be rejected from the commercial evaluation, even though the quoted rate is lowest.

4)Page no:22

5.76. No increase in the rate will be allowed during the period of contract or on extension period under any circumstances.

May be read as

5.76. No revision of any tax will be entertained at any cost during the contract period and on extension period except the revision of Collector wages on implementation in the Federation and corresponding EPF, ESI and GST.

5)Page no:27

7.01. The Garden Maintenance work should be done on all days including Sundays throughout the contract period by deploying 15 Nos. of workers (8 Male and 7 Female workers) at Ambattur Dairy Complex for two shifts from 7.00 am to 4.00 pm.

May be read as

7.01. The Garden Maintenance work should be done on all days including Sunday throughout the contract period by deploying 15 Nos. of workers (8 Male and 7 Female workers) at Ambattur Dairy Complex for General Shift from 7.00 am to 4.00 pm. (single shift).
